1. *Petitioner.* The Petitioner, **FATIMA OYELAMI**, is Decedent’s daughter and resides at 1713 Inwood Blvd., Garland, TX 75042
2. *Current Location.* Decedent is currently entombed in the Mausoleum at Greenwood Cemetery, located at 1428 Elm Hill Pike, Nashville, Tennessee 37210.
