What are Labor Surplus Areas?

Employers located in labor surplus areas, as classified by the United States Department of Labor, can be given preference in bidding on federal government contracts. The purpose in providing such a preference is to help direct the government's procurement dollars into areas where people are in the most severe economic need, i.e., areas with the highest unemployment rate.

Labor surplus areas are classified by civil jurisdictions rather than metropolitan or labor market areas. Civil jurisdictions are now defined as all cities with a population of at least 25,000 and all counties. A civil jurisdiction becomes a labor surplus area when its average unemployment rate was

at least 20 percent above the average unemployment rate for all states (including the District of Columbia and Puerto Rico) during the previous two calendar years. During periods of high national unemployment, the 20 percent ratio is disregarded. Instead an area is classified as a labor surplus area if its unemployment rate during the previous two calendar years was 10 percent or more. This 10 percent ceiling concept comes into operation whenever the two-year average unemployment rate for all states is 8.3 percent or above. Similarly, a "floor" concept of 6 percent is used during periods of low national unemployment in order for an area to qualify as a labor surplus area. The 6 percent "floor" comes into effect whenever the average

unemployment rate for all states during the two-year reference period is 5 percent or less.

The reference period used in preparing the current list was January 2004 through December 2005. The national average unemployment rate during this period (including data for Puerto Rico) was 5.4 percent. After applying the 1.2 ratio, the threshold for fiscal year 2007 is 6.5 percent. Therefore, areas are included on the current annual labor surplus area listing because their unemployment rates during the reference period were above the threshold. The fiscal year 2007 classifications will be in effect from October 1, 2006, through September 30, 2007.

SEPTEMBER

- Commonly Used Web Sites for Statistical Information. Also included is Job Bank USA, which is an online referral source, as well as wage data sites and the Consumer Price Index. All online publications from this division are included.

OCTOBER

- Foreign-Born Population in the Labor Force. This is a compilation of the numbers of naturalized citizens, permanent residents, undocumented persons, and refugees in Tennessee by gender. There is also a list of the foreign-born population in the southeastern states.

NOVEMBER

- The Number of Multiple Jobholders in the U.S. and in States, 2004 and 2005. Also included is demographic information on these moonlighters.

DECEMBER

- The ACCRA Cost-of-Living Index for Third Quarter, 2006. This is the cost of living in selected U.S. cities as figured by a survey from the nation's Chambers of Commerce Research Associations.

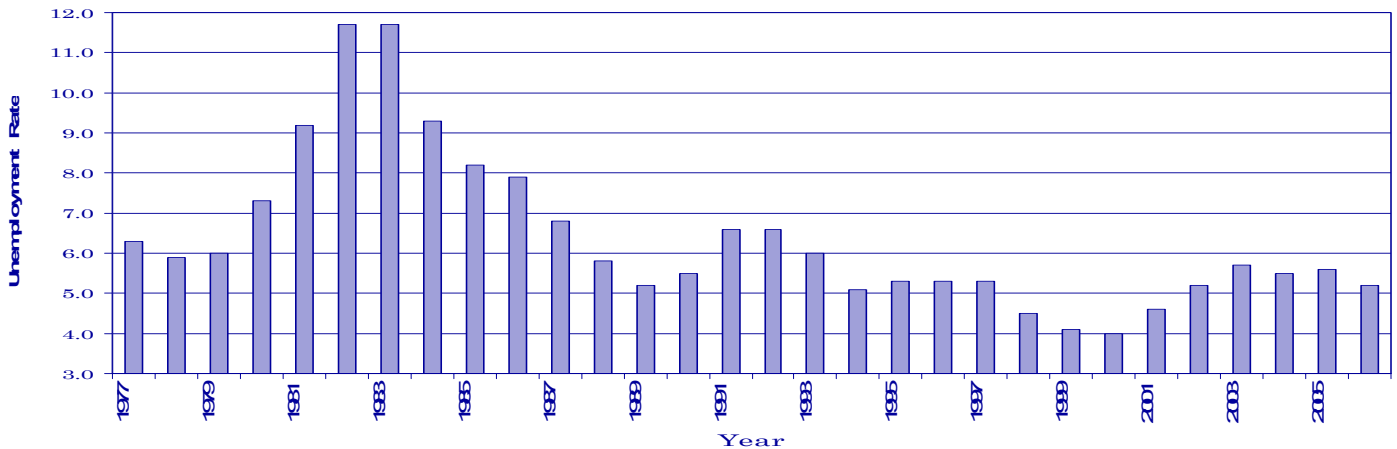

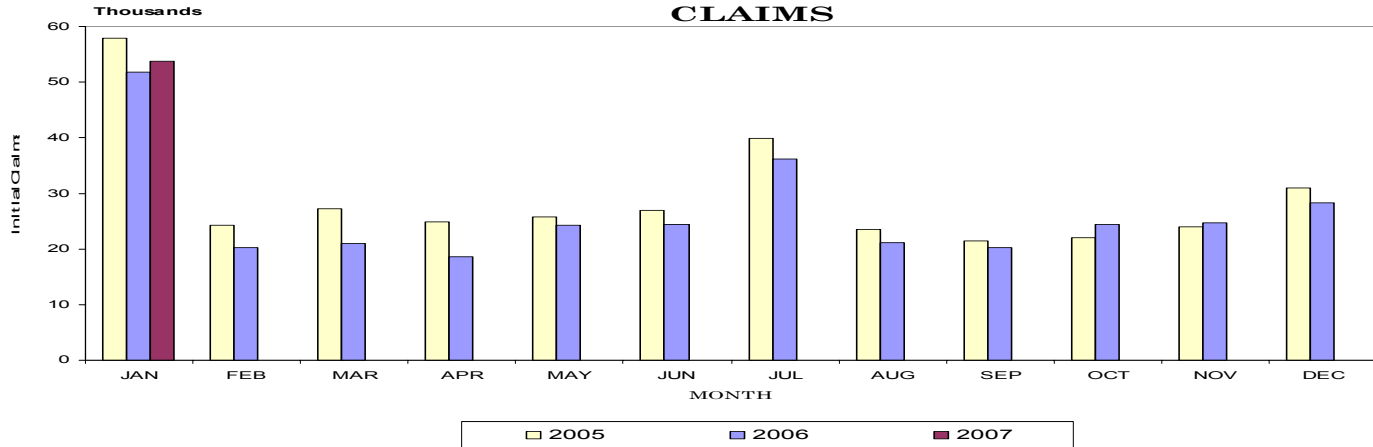
Unemployment Rates 1977-2006

MONTHLY INITIAL CLAIMS



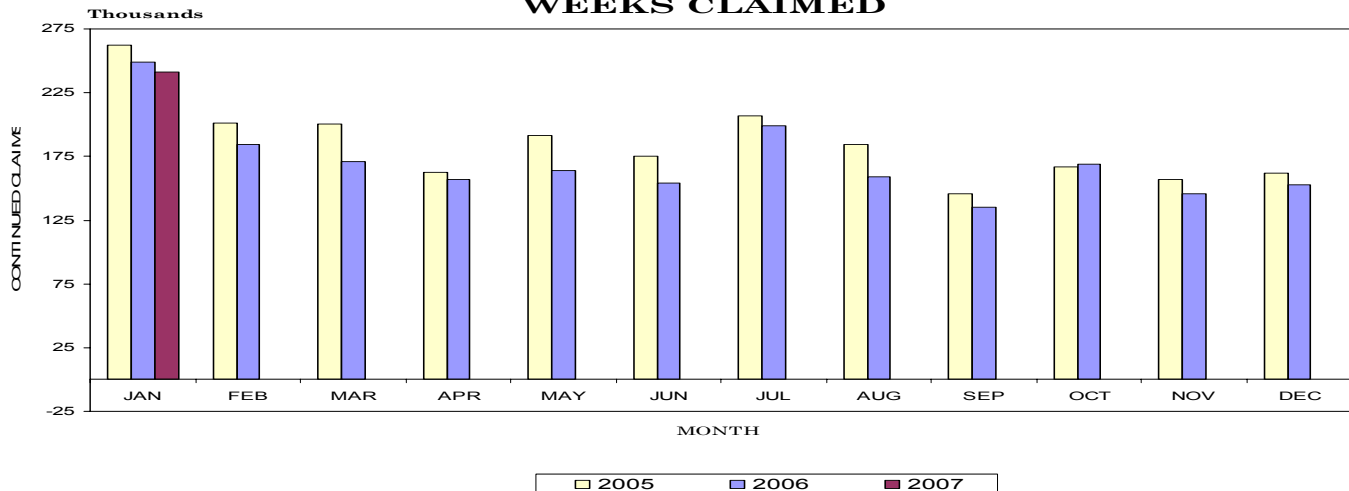

NONFARM EMPLOYMENT AND LABOR FORCE IN TENNESSEE

Tennessee's seasonally adjusted estimated unemployment rate for January 2007 was 4.8 percent, down 0.1 percent from the December 2006 rate. This is the fourth consecutive month that the current rate is greater than the national average.

The United States' unemployment rate was 4.6 percent in January 2007. In January 2006, the national unemployment rate was 4.7 percent, and the state's unemployment rate was 5.2 percent.

Across Tennessee, the unemployment rate increased in all 95 counties. The lowest rate occurred in Williamson County at 3.4 percent, up 0.4 percent from the previous month. The highest rate was Pickett County's 11.3 percent, up from 9.3 percent in December 2006.

(Continued from Page 5) Total nonfarm employment increased by 27,600 jobs from January 2006 to January 2007. During this period, there were increases in construction (up 8,200 jobs); educational/health services (up 7,600 jobs), which includes an increase of 6,600 jobs in health care/social assistance; accommodation/food services (up 7,300 jobs), which includes an increase of 6,700 jobs in food services/drinking; professional/business services (up 3,700 jobs), which includes an increase of 2,400 jobs in administrative/support/waste management; wholesale trade (up 2,500 jobs), which includes an increase of

1,600 jobs in durable goods merchant wholesalers; retail trade (up 2,200 jobs), which includes an increase of 1,700 jobs in building material/garden equipment/supplies; and truck transportation (up 2,000 jobs). This was partially offset by declines in manufacturing of 1,700 jobs in textile mills/products/apparel; 1,500 jobs in furniture/related product; 1,300 jobs in both motor vehicle parts and machinery; and 1,200 jobs in food.

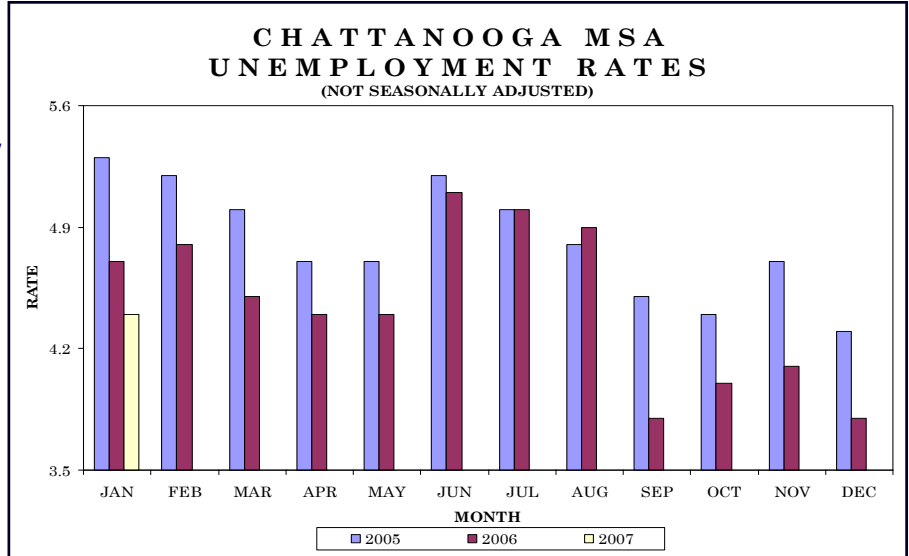
During January, nonfarm employment decreased by 61,800 jobs. There were seasonal declines in retail trade (down 16,600 jobs),

which includes decreases of 4,500 jobs in general merchandise stores and 4,300 jobs in clothing/clothing accessories stores; professional/scientific/technical services (down 14,700 jobs), which includes a drop of 12,900 jobs in administrative/support/waste management; leisure/hospitality (down 7,100 jobs), which includes a decline of 5,800 jobs in accommodation/food services; state government (down 5,500 jobs); and transportation/warehousing (down 3,800 jobs), which includes a drop of 1,400 in truck transportation.

The data from all the nonfarm employment estimates tables includes all full- and part-time nonfarm wage and salary employees who worked during or received pay for any part of the pay period that includes the 12th of the month. This is a count of jobs by place of work. Agricultural workers, proprietors, self-employed persons, workers in private households, and unpaid family workers are excluded. These numbers may not add due to rounding. Data is based on the 2005 benchmark.

Total nonfarm employment decreased by 3,200 jobs from December 2006 to January 2007. There were seasonal declines in retail trade (down 1,300 jobs), which includes a drop of 300 jobs in general merchandise stores; 400 jobs in state government; 300 jobs in both educational/health services and leisure/hospitality; and 200 jobs in natural resources/mining/construction.

During the past 12 months, nonfarm employment increased by 7,700 jobs. During that time, goods-producing jobs increased by 1,200, and service-providing jobs increased by 6,500.

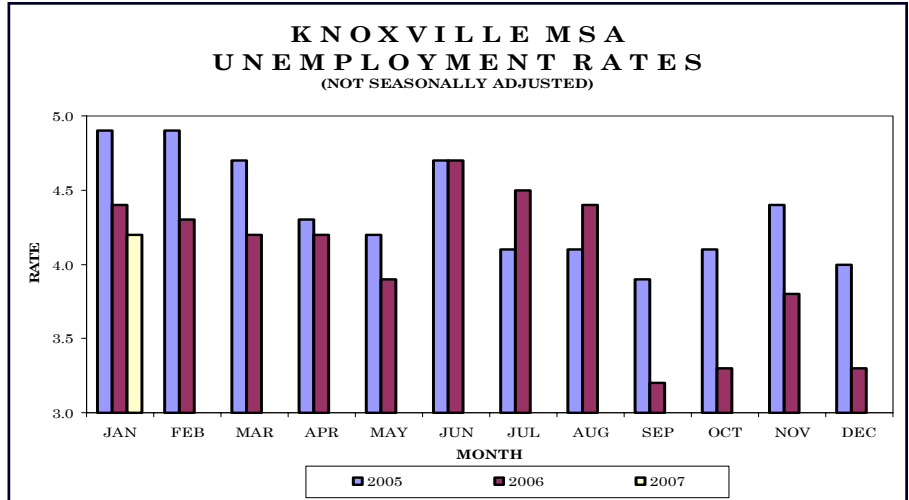

There were seasonal declines in retail trade (down 1,500 jobs), which includes a drop of 600 jobs in general merchandise stores and 200 jobs in food/beverage stores; accommodation/food services (down 1,000 jobs), which includes a drop of 900 jobs in food services/drinking places; administrative/support/waste management and state government (both down 800 jobs); educational/health services (down 400 jobs); local government (down 300 jobs); and other services, transportation/warehousing/utilities, and financial activities (all down 200 jobs).

During the past 12 months, nonfarm employment increased by 6,200 jobs. During that time, goods-producing jobs increased by 1,200, while service-providing jobs increased by 5,000.

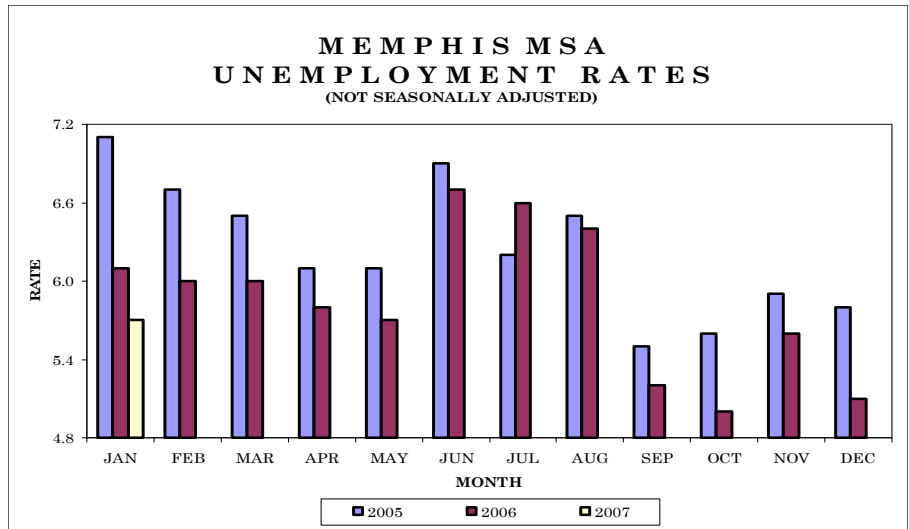

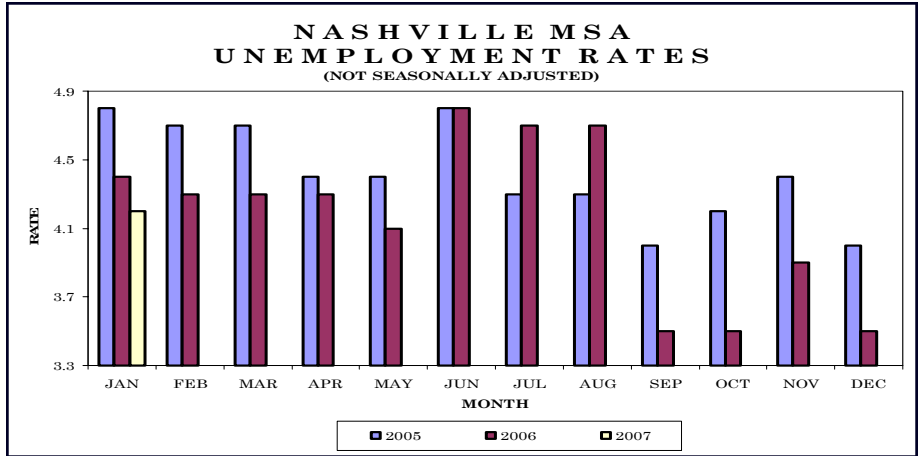
