World Statistics Day 2010

The United Nations' General Assembly designated Oct. 20, 2010, as the firstever World Statistics Day to highlight the role of official statistics and the many achievements of national statistical systems. Statistical organizations throughout the world celebrated World Statistics Day at the national and regional level.

The U.S. government has a long history of collecting statistics about the nation's people, economy, and society beginning with the first national census in 1790. Today, 15 federal agencies collect or publish the statistics the nation uses to record progress and plan for the future. They include the Bureaus of Economic Analysis, Justice Statistics, Labor Statistics. Transportation

Statistics, and the U.S. Census Bureau. There are also statistics from National Agricultural Statistics. National Center for Education, National Center for Health Statistics. Science Resources Statistics, Social Security Administration Statistics, and the Internal Revenue Service's Statistics **Division**. Completing the list of federal statistical agencies are the Economic Research Service. Energy Information Administration. Office of Environmental Information, and the National Science Foundation. The U.S. Census Bureau Web site includes links to 230 international statistical agencies.

Population Stats

There are approximately 310 million Americans. On Dec. 31, the 2010 Census population for the nation and each state will be released. At our independence in 1776, we had a population of 2.5 million. In 1915, we reached 100 million persons. The country had 200 million persons in 1967 and 300 million in 2006. Women accounted for 50.2 percent (155.6 million) of the resident population, while there were 151.4 million males. In Tennessee, women accounted for 51.3 percent of the population. In 2009, there were 11 states. however, where men outnumbered women. These states are Alaska, Arizona. California, Colorado, Hawaii, Idaho, Montana, Nevada, North Dakota, Utah, and Wyoming. All of these states are west of the Mississippi River. There were an estimated 70,490 centenarians in the United States as of

2009. It is projected that by 2050, the number will increase to more than 600,000.

Education

As of 2009, 85 percent of Americans over 25 had a high school diploma. Twenty-eight percent of that group had at least a bachelor's degree. As of 2008, 81.8 percent of Tennesseans over 25 had a high school degree. Twenty-two percent of that group had at least a bachelor's degree. From 1999 to 2009, the number of U.S. residents that earned a bachelor's degree has increased from 43.8 million to 58.6 million. This is an increase of 34 percent.

Nine percent of all females and 6 percent of all males between the ages of 25 and 29 have a master's degree, a doctoral degree, or a professional degree. In Tennessee. this ratio was reversed as 8.1 percent of males had earned a master's degree or greater. while 7.4 percent of the female population had the same degree attainment. Many more women (58 percent) than men under 29 years old have earned a professional degree in the United States.

Children

There were 74.5 million U.S. residents under 18 years old in 2009. Seventy percent of those children lived with both parents in 2009. Eighty-four percent ate dinner with a parent five or more times per week in 2006.

There were 5.3 million "stayat-home" parents in 2009 in the United States. Five million-one hundred thousand mothers stayed at home, while only 158,000 fathers were at home.

Fifty-nine percent of children ages 6 to 11 were highly engaged in school in 2006. "Highly engaged" is defined as whether a child is interested in schoolwork, works hard in school, and likes school. There are family television limits for 56 percent of all children. Parents or guardians limit what programs children may watch. what times of the week, and the number of hours they may watch television. Of children between the ages of 6 and 17, 42 percent participated in sports and 33 percent participated in extracurricular clubs in 2006.

Statistician Statistics

There were 29,208 statisticians employed in the United States in 2009. Twenty percent of all statisticians were employed in the 14 agencies mentioned in the first paragraph. Most of them were concentrated in the Departments of Commerce, Agriculture, and Health and Human Services in 2008. Another 10 percent worked for state and local governments.

The projected national growth rate for statisticians is 13 percent from 2008-2018. The median annual wage for a statistician was \$72,820 in 2009. In Tennessee, there were 410 statisticians employed in 2008. The statewide projected growth for this occupation is 7.3 percent from 2008-2018. The median annual wage for a statistician was \$53,080 in 2009.



Unemployment Rates 1980-2009





NONFARM EMPLOYMENT AND LABOR FORCE IN TENNESSEE

Total nonfarm employment increased by 22,600 jobs from October 2009 to October 2010. This includes increases in professional/ business services (up 10,700 jobs), which includes job gains of 9,800 jobs in administrative/support/ waste management; retail trade (up 7,600 jobs); health care/social assistance (up 6,900 jobs), which includes an increase of 2,200 jobs in ambulatory health care services and 2,000 jobs in social assistance; wholesale trade (up 2,600 jobs), which includes an increase of 2,000 jobs in wholesale trade durable goods; fabricated metal products (up 2,500 jobs); accommodation/food services (up 2,300 jobs), which includes an increase of 1,800 jobs in food services/drinking places; and educational services (up 1,800 jobs). This was partially offset by decreases in information (down 2,900 jobs), finance/insurance (down 2,500 jobs), mining/logging/construction (down 2,400 jobs), state government (down 1,600 jobs), and transportation/warehousing (down 1.500 jobs).

During October, nonfarm employment increased by 7,100 jobs. The largest seasonal increases were in administrative/support/waste management (up 3,100 jobs); local government educational services (up 2,500 jobs); retail trade (up 2,300 jobs), which includes an increase of 1,000 jobs in clothing/ clothing accessories stores; state government educational services (up 1,800 jobs); and educational services (up 1,700 jobs).

Tennessee's seasonally adjusted estimated unemployment rate for October 2010 was 9.4 percent, unchanged from the September 2010 rate. This is the third month in a row that the current rate is less than or equal to the national average.

The United States' unemployment rate was 9.6 percent in October 2010. In October 2009, the national unemployment rate was 10.1 percent, and the state's unemployment rate was 10.8 percent.

Across Tennessee, the unemployment rate decreased in 43 counties, increased in 38 counties, and remained the same in 14 counties. There were 42 counties with an unemployment rate less than 10 percent and two counties had a rate above 15 percent. The lowest rate occurred in Lincoln County at 6.1 percent, up 0.1 percent from the previous month. The highest rate was Scott County's 19 percent, down from 19.8 percent in September 2010.

The data from all the nonfarm employment estimates tables include all full- and part-time nonfarm wage and salary employees who worked during or received pay for any part of the pay period that includes the 12th of the month. This is a count of jobs by place of work. Agricultural workers, proprietors, self-employed persons, workers in private households, and unpaid family workers are excluded. These numbers may not add due to rounding. Data is based on the 2009 benchmark.
